CROSS BORDER MATTERS

Bangladesh is one of the leading manufacturers of garments, pharmaceuticals and leathers goods which involves a high volume of international trade in different parts of the world. In the absence of any arbitration clause the only recourse available is to rely on the conflict of laws principle and select appropriate forums where the matter can be brought before Court of law.

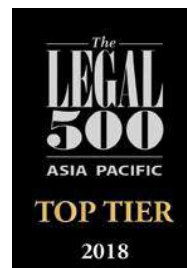
